Three months ago, I stepped into the role of CEO at India Animal Fund (IAF) – a **'backbone organisation'**. I was unfamiliar with the term and intrigued by the underlying principle of such organisations: shared ownership of a common agenda with neutral, backbone-level coordination that enables every other actor to move faster and farther together than any could alone. Simply put, backbone organisations are not and will never be the stars of the show but remain supporting actors, staying backstage, and doing whatever is necessary for the show to go on. **IAF is working hard to play this role for the animal welfare movement.** 

# Why is this Important in Animal Welfare?

Two billion animals are in Indian systems, **10,000+ animal protection organisations** work in India, and **yet a little over 0% of strategic funding** goes towards the animals. IAF is working to change this asymmetry by positioning animal welfare within the interconnectedness of animal, human and planetary health.

Animals suffer in many ways -- in factory farms, in labs, and on our streets. IAF aims to reduce the suffering of all these animals; however, our primary focus is on animals farmed for food due to the magnitude and intensity of their suffering. Through our partners' work, we engage with several topics and themes including climate action, health and plant-based nutrition, animal protection, humane education, awareness building, legal and policy frameworks, alternative proteins, and so much more.

#### **Our Six Focus Areas for the Next Five Years**

- Awareness/ Education
- Al for Animals
- Sustainability
- Nutrition
- Alternative Protein
- Welfare standards

Each of these themes has **bold 5-year goals**, **ongoing partner projects**, **and new projects** in the pipeline. To address this growing public health concern, **Physicians Association for Nutrition**, **India** have launched, 'A Physician's Guide to Vitamin B12 in the Evolving Dietary Landscape' - a comprehensive clinical resource for healthcare providers **which brings attention to plant-based B12 sources as alternatives to the more commonly prescribed animal-based options**.

The guide covers the biological role of B12, dietary sources, absorption, deficiency symptoms, diagnostic tools and treatment protocols, and equips physicians to play a frontline role in prevention and care. It is a valuable reference for nutritionists, educators and students working to advance evidence-based nutrition in healthcare.

India's First Cage-Free Demonstration and Training Facility Launches in Trichy

In a major step toward changing this, India now has its first cage-free demonstration and training facility for egg production in Trichy, Tamil Nadu. **Enabled by Global Food Partners, People for Animals Public Policy Foundation and the Cage-Free and Free-Range Poultry Producers Association** in collaboration with a coalition of partners, the climate-controlled facility houses 10,000 hens and will serve as a national hub to train farmers and producers in higher-welfare, cage-free practices.

This marks a significant milestone in advancing animal welfare and in aligning Indian egg production with global trends and rising demand for ethically sourced food.
